<u>Eligibility:</u> The Bidders should have executed one similar type of work value not less than 0.56 lakh or two similar works value not less than 0.35 lakh or three similar works value not less than 0.28 lakh in last three financial years and completed similar type of works in any Govt. organizations/IITs/NITs/autonomous bodies or any RO manufacturer that having MSME is eligible for participation in tendering.

- 1. <u>Documents:</u> Tender paper in complete shape signed in all the pages with the filled in item rate should be submitted along with the competitive and justified rate with specifications & makes including all relevant documents like copies of Registration certificate, PAN no , GST Registration, Trade License, IT Return for last three financial year, work experience certificate etc., in a sealed cover addressed to the undersigned super scribing the name of work so as to reach within <u>28.12.2023 up to 15:00 hrs</u> positively. Late submission or any postal delay will not be accepted.
- 2. The vendor should have registered local office in Kolkata or vicinity of Kolkata.
- **3. 'Similar type works'** means the bidders should have well experience in RO installation/repairing/maintenance works etc.

#### **Terms and conditions:**

- 1. **Tender fee and EMD** is exempted for MSME certificate holder with current financial year and having MSME related to the similar works specified in tender.
- 2. The performance security will be considered 5% of the contract value and the contractor should submit it in the form of cheque/DD/FR/PBG in the name of IISER Kolkata or online payment as per said bank account within 15 days after issuing of the intimation letter to the concern agency.
- 3. Vendor should supply the item as per BoQ mentioned in NIT and necessary approval should be taken from department.
- 4. The vendor shall pay as liquidated damage 1% of the work order value per week subject to maximum 10% of the work order value for any delay in completion of the work beyond the stipulated period.
- 5. The payment will be made after entire completion of the work as per order and against challan & tax invoice.
- 6. The price shall be valid for 120 days from the date of opening of the tender.
- 7. The vendor should carry **six month warranty** period after completion of the repairing works and submission of final testing report to the department.
- 8. The security money will be deducted 5% of the final bill value and it will be released after successful completion of 12 month maintenance period.
- 9. The work should be completed within 30 days from the date of handing over of the site. No extension shall be granted to the contractor unless the reasons are beyond his control and the engineer in-charge is satisfied with the reasons.
- 10. The vendor should take care the existing property of the institute and any damage during the works, vendor should pay/institute have rights to deduct the chargeable amount from the bill.
- 11. Items should be reached to IISER Kolkata Mohanpur campus.
- 12. The quoted amount should be inclusive of all taxes, duties, transportation charges etc. and is to be written clearly both in figure and in words.
- 13. Preventive and break down maintenance:
  - a. Scope included quarterly servicing of the plant accessories, machineries etc. and checking.
  - b. Scope included any break down call and rectifications for electrical and mechanical faults.
  - c. Any break down call should be attended within 24 hrs.
  - d. Spare parts or any consumable items are not included in maintenance contract.
