<u>Eligibility</u>: The Bidder should have executed one similar type of work of value not less than 1 lakh or two similar works not less than 0.5 lakh or three similar works not less than 0.4 lakh in last three financial years and must have turnover of Rs. 0.3 lakh in last three financial years. The bidder should have completed such type of work in any Govt. /Reputed organization. Documents must be submitted with tender.

Documents: Tender paper in complete shape signed in all the pages with the filled in item rate should be submitted along with the competitive and justified rate with specification & makes including all relevant documents like copies of **Registration certificate**, **PAN no.**, **Dealership**, **GST Registration**, **Trade License**, **IT Return for last three financial year**, **work experience certificate** etc., in a sealed cover addressed to the undersigned super scribing the name of work so as to reach within <u>11.01.2021 upto 15:00 hrs</u> positively. Late submission or any postal delay will not be accepted.

Terms and conditions:

- 1. The earnest money deposit and tender paper cost have to be submitted in the form of NEFT/RTGS only. The earnest money will be refunded to all the bidders and successful bidder should submit the performance security 3% of the contract value in the form of cheque/DD/PBG as bank guarantee in the name of Superintendent Engineer, IWD, IISER Kolkata within 15 days after issuing of intimation letter to the contractor. Cost of tender papers will not be refunded. Also vendor should submit the bank details for refund of the earnest money with tender documents.
- 2. The work should be started immediately after issuing of the work order.
- **3.** The quoted amount should be inclusive of all taxes, duties, transportation charges etc. and is to be written clearly both in figure and in words.
- 4. All the tools and tackles should be provided by the vendor.
- 5. Vendor should take care the existing property of the institute. Any damage during the work, the vendor is responsible for pay /Institute should deduct the amount from the bill.
- 6. Vendor should responsible for any injuries to the workers during the work.
- **7.** The work order may be awarded on the basis of the competency and reliability of the bidder and quoted offer and it is not necessarily to award the contract to the lowest bidder.
- 8. The complete tender may be sent by post to the above mentioned address captioned "Supply, installation, testing and commissioning of split type stand air conditioner at FESEM lab in A J C Bose Research Complex". The envelope should be addressed to The Superintendent Engineer (IWD). - **9.** All the above said relevant documents with NEFT/RTGS details scanned copies must be reached to the above said address within scheduled date and time.
- 10. The rates quoted by the Contractor shall include for supplying materials and labour necessary for completing the work in the best and most workmanship like manner to the satisfaction of the Institute and for maintaining the same. The rates shall be complete in all respects also including cost of materials, erection, fabrication, labour, supervision, tools and plant, transport, sales and other taxes royalties, duties and materials, contingencies, breakage, wastage, sundries, scaffoldings, etc., on the basis of works contract. The rates quoted shall include all taxes, duties, transport, supervision, GST or any other levies applicable under the statute including comprehensive warranty obligation as mentioned in the BOQ. The rates quoted by the Contractor shall be net so as to include all requirements described in the contract agreement and no claim whatsoever due to fluctuations in the price of material and labour will be entertained. No change in unit rate will be admissible on any variation of quantity.

- 11. **Completion period:** The contractor should complete the work within 30 days after handing over of the site. No extension shall be granted to the contractor unless the reasons are beyond his control and the engineer in-charge is satisfied with the reasons.
- **12. Warranty period:** The contractor should carry 1 year warranty on machine. During warranty period the vendor should attend any kind of fault within 24 hrs after lodging the complain. Otherwise the institute has right to deduct the chargeable amount form the security money. The vendor will take responsibility to repairing/rectification of the machine. Department will not directly communicate to OEM for any kind of fault.

13. Scope of work

- a. The vendor should take approval of the air conditioning unit as per BoQ specifications and after approval from department the concern vendor will start the work.
- b. Wall core cutting, drilling, welding and saddling etc in contractor scope of work.
- c. The indoor and outdoor iron stand should be painted.
- d. Carrying /lifting of AC unit one place to another place.
- e. Proper insulation on copper pipe with wrapper.
- f. Saddling on copper pipe.
- g. Split AC fixing and complete installation.
- h. Indoor to outdoor cable laying.
- i. Providing of drain line.
- j. Gas charging.
- k. Remote testing with battery.
- I. Copper pipe leakage testing.
- m. Electrical connection and necessary testing.
- **14.** Bid validity: The price shall valid till 120 days after opening of the tender.
- **15. Payment:** The vendor should submit the bill after completion of the entire work. The already deposited performance security keeps as security deposit for one year after submission of completion/warranty certificate to the department. After successful completion of one year the security deposit may release.
- **16.** The vendor should submit the necessary test certificate, warranty certificate and measurement sheet to the department after completion of work.
