ORDER

In order to contain the increasing rate of infection of COVID 19 within specific areas in Nadia district and in pursuant to Paragraph 7 of the order vide memo no. 285- CS/ 2020 dated 30th July, 2020 of the Chief Secretary to the Government of West Bengal, comprehensive lockdown is being declared in the following areas (which are declared as extended containment zones as well) with effect from 7th August, 2020, Friday, midnight 11.59 pm to 14th August, 2020, Friday midnight 11.59 pm.

The following activities/establishments will remain closed / prohibited during the above mentioned period in the above said areas:

1. All offices, government and private (except the offices providing essential services, Health Services and involved in COVID management, Treasury, Banking, MDM and ICDS Distribution, PDS Distribution, Law and Order, Disaster Management, Electricity, Fire and Emergency, Courts and Correctional Homes);
2. All religious, social activities (except for marriages and last rites of deceased within the allowable participant limit);
3. All market complexes and shops;
4. All Roadside dhabas, tea stall, eateries etc;
5. All public and private transport for carrying people (except long distance public buses / vehicle passing through the area, specially, by National Highway & State Highway, without allowing any stoppage within the abovementioned areas).

However, activities as exempted during complete lockdown (ref: paragraph '6b' of the order of the Chief Secretary, Government of West Bengal by memo no. 285-CS/ 2020 dated 30th July, 2020) shall be exempted activities during this period of seven days lockdown in these areas.

It is advisable that the required essential items for seven days of lockdown period are stored beforehand as far as possible, so that the need to come out during the lockdown period does not arise.

On the day(s) of state wide lockdown, restrictions/exemptions imposed by the Chief Secretary, Govt. of West Bengal vide memo no. 285-CS/ 2020 dated 30th July, 2020 will be in force.

This order has been issued as COVID-19 containment measure and appropriate publicity measures will be undertaken to make the public at large be aware of this.
