## **ORDER**

Subject: Cancellation of Order vide Memo No. 1380/Health dated 5<sup>th</sup> August 2020 and announcement of strict containment measures on 13<sup>th</sup> and 14<sup>th</sup> August 2020 in specific areas in Nadia district

Whereas, several requests and appeals have been received from different quarters to relax the order vide Memo No 1380/Health dated 5<sup>th</sup> August 2020 issued by the undersigned;

#### And

Whereas, after detailed analysis of occurrence of COVID 19 cases during recent past in the context of geographical distribution and frequency and in view of spatial locations of containment zones and considering the population density and floating population, it is felt that larger containment zones are required to be defined;

### And

Whereas it is also found that stringent containment measures (as detailed below) need to be imposed and enforced for the purpose of slowing down the spread of the infection;

### And

Whereas, paragraph 7 of the order vide memo no. 285- CS/ 2020 dated 30<sup>th</sup> July, 2020 of the Chief Secretary to the Government of West Bengal, authorizes the District Magistrates to enforce stricter measures in this regard;

Therefore, containment measures (as detailed below) shall be enforced in extended containment zones as mentioned in the following table with effect from 00.01 hours on 13<sup>th</sup> August, 2020, Thursday to 23.59 hours on 14<sup>th</sup> August, 2020, Friday.

## **Containment Measures in Extended Containment Zones:**

- 1. Strict perimeter control shall be enforced;
- 2. Egress and ingress into and from these zones shall be restricted;
- 3. Movement of people within the zones shall be restricted;
- 4. All offices, government and private shall be closed. (except the offices providing essential services, Health Services and Services involved in COVID management, Treasury, Banking, MDM and ICDS Distribution, PDS Distribution, Law and Order, Disaster Management, Electricity, Fire and Emergency, Courts and Correctional Homes);
- 5. All religious, social activities shall be restricted (except for marriages and last rites of deceased within the allowable participant limit);

- 6. All market complexes and shops shall be closed (except for essential items);
- 7. All Roadside dhabas, tea stalls, eateries etc. shall be closed;
- 8. No public and private transport for carrying people shall ply (except long distance public buses / vehicle passing through the area, specially, by National Highway & State Highway, without allowing any stoppage within the abovementioned zones).

However, activities as exempted in the order of the Chief Secretary at paragraph '6b' vide memo no. 285-CS/ 2020 dated 30th July, 2020 shall be exempted activities.

On the days of state wide lockdown (Memo no. 287-CS/ 2020 issued by the Chief Secretary, Government of West Bengal dated 03.08.2020) restrictions/exemptions imposed vide memo no. 285-CS/ 2020 issued by the Chief Secretary, Government of West Bengal dated 30th July, 2020 will be in force.

This order has been issued as COVID-19 containment measure and appropriate publicity measures will be undertaken to make the public at large be aware of this.

Thus, this office order vide Memo No: 1380/ Health dated 5th August, 2020 stands cancelled.
