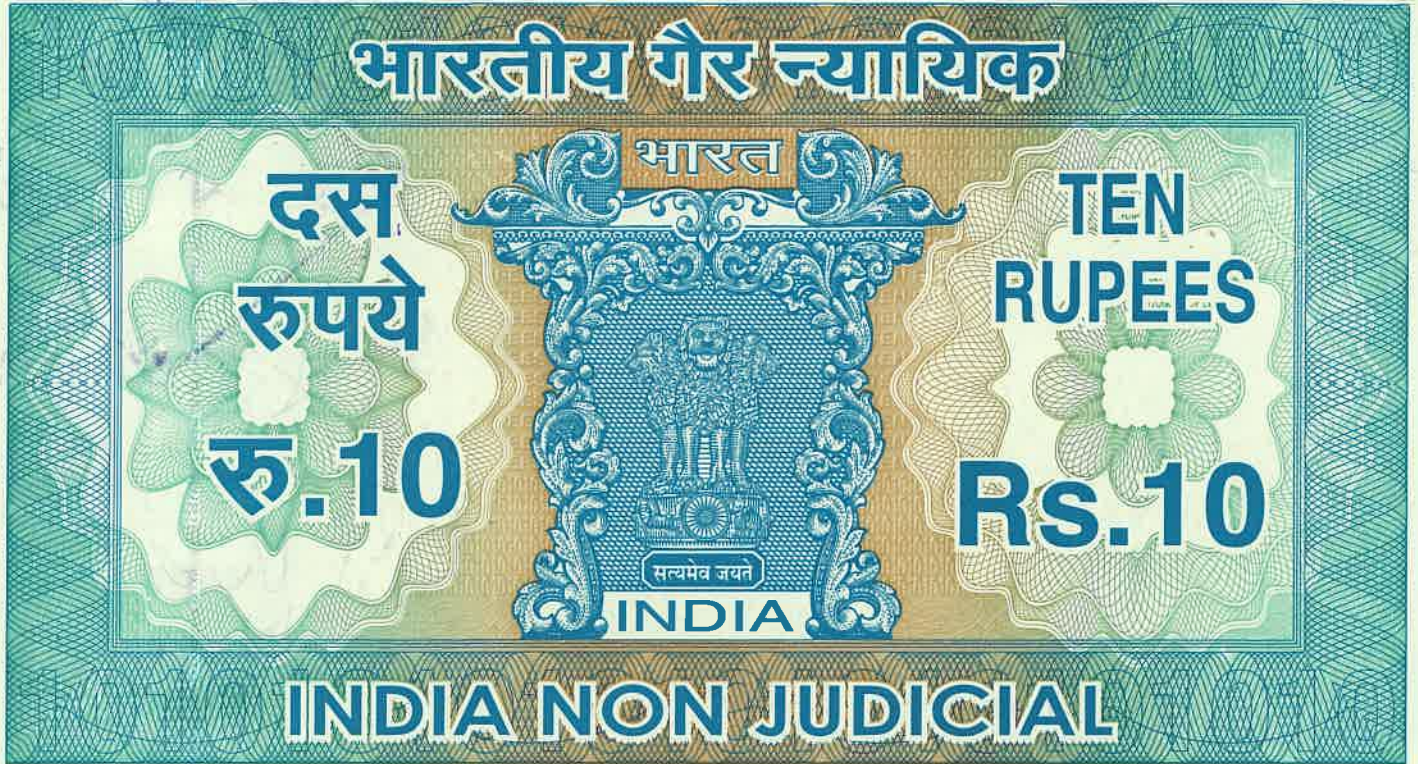

This MOU is at will and may be modified by mutual consent of authorized officials from both Parties. This MOU shall be effective upon the signature of Batoi Systems Pvt Ltd and Indian Institute of Science Education and Research Kolkata authorized officials.


