This MEMORANDUM OF UNDERSTANDING is made on the first day of January Two Thousand and Twenty BY and BETWEEN Indian Institute if Science Education &Research (IISER), Kolkata, an Autonomous Institute, Ministry of Human resource Development, Govt. of India, located at Mohanpur, West Bengal, Pin-741246, hereinafter referred to as the IISER of the ONE PART;

AND

The College of Medicine & JNM Hospital, West Bengal University of Health Sciences, Government of West Bengal, located in Kalyani West Bengal hereinafter referred to as the "COMJNMH" of the OTHER PART;

WHEREAS IISER AND COMJNMH being desirous of collaborating on scientific activities , including education and capacity building , of mutual interest, for the promotion of medicine and public health, decided to collaborate with each other,

This Memorandum of Understanding defines the interests, roles and responsibilities of the participating institutions,

## NOW THE INSTITUTIONS HERETO AGREE AS FOLLOWS:

Education: the post graduate students and other students of relevant courses conducted by IISER and WBUHS can avail the facilities of training from either of the institution which is not available in the respective institute.

2. Research: Joint participation in the research projects of mutual interest related to medicine & Public health, including the proposals submission to funding agencies and sharing the facilities, infrastructure and manpower for execution of the research projects,

#### DURATION

Duration of this Memorandum of Understanding shall be FIVE years from the date on which, it is signed by the authorized signatories of IISER and COMJNMH. It can be renewed every five years depending in situation.

### PROTECTION OF NATIONAL INTEREST

Both IISER and COMJNMH agree not to undertake any activities that may be detrimental to the interests of the Indian nation, and agree to abide by the ICMR Ethics Guidelines for the conduct of research involving human subjects and CPCSEA animal ethics guidelines.
