This Memorandum of Understanding (MoU) is made between

(A) Institute of Data Engineering, Analytics and Science Foundation (IDEAS), Technology Innovation Hub (TIH), Kolkata A Section-8 Company set up at the Indian Statistical Institute, Kolkata under a National Mission on Interdisciplinary Cyber-Physical Systems (NM-ICPS) program of the Government of India.

AND

(B) Indian Institute of Science Education and Research, Kolkata (IISER-K).

Institute of Data Engineering, Analytics and Science Foundation (IDEAS), Technology Innovation Hub (TIH), Indian Statistical Institute, Kolkata, and Indian Institute of Science Education and Research, Kolkata (IISER-K) are two leading institutions of higher education in India. To promote collaborative research to work on areas of mutual interest, the IDEAS-TIH and IISER-K, the two organizations, agree to the following broad terms of cooperation.

- 1. Both the organizations will support each other's endeavors in delivery of academic programmes and research activities of the IDEAS-TIH and IISER-K through the following, but not limited to:
 - a) Visit of faculty/staff/student in areas of mutual interest
 - b) Exchange of scientific and technical information
- c) Undertake collaborative research activities through participation in funded projects
- d) Joint supervision of graduate, postgraduate and Ph. D. students
- e) Training of students as per the facilities and resources available
- f) Jointly organize events such as seminars, workshops, conferences and training programmes
- g) Sharing of library facilities
- h) Any other matter/s as agreed which are not covered above
- 2. Both parties acknowledge and understand that all financial arrangements, if any, will be subjected to prior written agreement and availability of funds for each activity/project undertaken.
- 3. The MoU remains in place for a period of five years from the date of signing of the agreement and may be renewed for a further period of five years or such time period as agreed by both the parties in writing.
- 4. No party shall have the right to use the name/acronym or logo/official emblem of another party without the prior approval of that party in writing.
- 5. The terms of this MoU may be modified/amended at any time subject to mutual written agreement. Such modifications/changes shall be effective from the date on which both the parties execute them in writing.
- 6. The MoU may be terminated by either party by giving 3 months written notice. In the event of termination, both parties shall ensure that the interest of students working/projects under this MoU is safeguarded to the extent possible.
- 7. The parties acknowledge and agree that electronic communication is an acceptable method of correspondence and communicating information between the parties without having to communicate the same on paper. Any communication and subsequent electronic signature that has been sent or signed in the past, present, or future between the Parties will hold the

same force and effect as a document signed and inked on paper,

RESPONSIBILITIES OF THE PARTIES

Both parties mutually agree to identify various areas of interest and depute faculty/staff/student as per the requirements with mutual consent. The parent institution shall meet the travelling expenditure, while the inviting institution shall make necessary boarding and lodging arrangements for the deputed person/visiting faculty/staff/student.

Both parties shall organize regular interactions/meets to promote research interaction and collaboration among their faculty members.

Every individual research collaboration will have separate agreement/terms of contract that addresses issues such as Intellectual Property Right (IPR), funding pattern, disclosure of confidential information etc.

In the event of any dispute or difference arising in the implementation of the MoU, such disputes shall be resolved amicably by mutual discussions. All such decisions shall take into account the status of students working/projects under this arrangement and the interest of such students/projects shall be guarded as much as possible.

Now, based on the aforementioned promise(s), the parties put their signatures on this MoU on May Day of 10, 2023.
